

MOTOR THIRD PARTY LIABILITY INSURANCE

If your vehicles cause accidents, the motor third party liability insurance provides compensation for damages caused to third parties

The insurance is compulsory and should start to apply on the same day as you take over ownership of the vehicle.



The third party car insurance policy ensures that if you or your drivers cause an accident, any damage to the other person's vehicle or property will be paid for by your insurer. The insurance also covers the compensations for bodily injury and death caused to third parties.

What does Motor Third Party Liability Insurance cover?

The insurance is intended for companies owning motor vehicles, temporarily or permanently registered in Romania.

The Motor Third Party Liability insurance covers your civil liability for damages generated to a third party by your vehicle. The compensation limits for damages produced on the territory of Romania are established by the legislation in force. The compensation limits for damages produced outside Romania, are established in accordance with the legislation in force in the state in which the accident occurred, with the highest level of compensation between the one provided in the legislation of that state and the one provided in the insurance contract.

The covered risks include:

- personal injury or death
- material damages
- damages resulted from the impossibility to use the damaged vehicle
- legal costs incurred by the damaged / injured person

The motor third party liability insurance alone is not enough to protect your vehicles against damages from accidents produced from your fault, or damages caused by theft or severe weather. For all of these, you need comprehensive motor vehicle insurance.
